The National Live Music Office works to increase opportunities for live music in Australia by identifying and advocating for better policy, regulation and strategy.



Australia has a long and proud history of live music. Not only have we produced major international touring acts, but for many of us attending local shows is a fundamental part of our cultural and social lives. Indeed, a 2011 study in Victoria found more people attended live music annually than AFL games.

Like most forms of creative enterprise, the music sector has had to adapt in the face of digital platforms and changing audiences. Despite its ongoing popularity, strict regulation and convoluted policies have produced significant obstacles for musicians, venues, punters and the industry as a whole. As early as 2004, Chris Gibson and Shane Homan wrote, "the splintering of music communities, community resources and spatial 'responsibilities' awaits a coordinated policy response." The Live Music Office was formed to address this concern.

Previously, lanto was CEO of Renew Adelaide and founding director of the Format Collective, a not-for-profit production house and venue in South Australia. He also holds a PhD in Cultural Studies and has worked as a librarian, researcher, consultant, and policy advisor on urban renewal, regulatory reform, media and social inclusion. Moreover, he has been playing in bands since 1995.

John Wardle is a working musician and teacher with a background in live music policy across the three tiers of government. John has played a strategic role in liquor law reforms across a number of states, as well as in the changes to NSW Place of Public Entertainment (PoPE) laws and the associated NSW Building Code of Australia variation. In 2013 John was appointed Chair of the City of Sydney's Live Music Taskforce in 2013 John has been an advisor to the NSW Parliament across a range of portfolios. John was a guitar teacher and program co-ordinator at the Sydney Conservatorium of Music from 2000-2006 as well as teaching at the Australian Institute of Music and the Guitar Factory at Gladesville in recent years, and tours regularly as a sideman on guitar at both a national and international level.
